





Integrated Conferencing System / Presentation Judging

- Team first enters Waiting Room
 - Teams may talk among themselves, practice presentation, etc. until judges are ready
 - **Recommended**: Join early so team is ready for interview
- Judges directly enter Main Session
- Once judges are ready, they will move your team from Waiting Room to Main Session
- Judges will let you know when to start and stop (15 minute interview)



Integrated Conferencing System / Follow-up Judging

- Equivalent to "Pit interviews" at in-person event
- Teams directly join Main Session
 - Teams may talk among themselves until judges join
 - Teams must remain in session for entire duration (45 minutes)
- Judge teams (2-3 judges per team) will join your session when they are ready to ask follow-up questions
- At least one judge team will visit your team
